COURSE IN HOSPITAL

Patient admitted in hospital through causality on 17.05.2020 under Dr.A.K.Verma with above mentioned complaints. After initial evaluation, as per standardised protocol treatment imitated with IV fluids, IV antibiotics, and oral Antipyretic, and other supportive treatment also given. All necessary investigations were done. Under all aseptic precaution dressing done on alternate days. Patient responded well to given treatment, condition of patient has improved. Today patient is being discharged with following advice and medication in stable condition.
